A policy service charge of \$50 is not included in these charges, but will be deducted each year from the policy's accumulation value on the policy anniversary and upon surrender of the policy if on that date the Accumulation Value is below \$100,000. The performance shown, therefore, would be slightly lower if your policy's accumulation value is less than \$100,000. Performance "Assuming No Surrender" does not reflect the deduction Surrender Charges (SC). If reflected, the performance would be reduced. Performance "Assuming Surrender" reflects the maximum SC. The maximum SC for each payment is 8%, declining to 7% by the 3rd year after that premium payment has been in the policy, with no charge thereafter. Withdrawals and surrenders may be taxable transactions, and prior to 59½, may be subject to a 10% IRS penalty (the penalty tax is increased to 25% in the case of a distribution from a SIMPLE IRA within the first two years of your participation in the SIMPLE IRA plan). The Investment Divisions offered through the New York Life Select Variable Annuity and described herein are different from mutual funds that may have similar names but are available directly to the public.
